- I, declare as follows:
  - 1. As a teenager, I fell in with the gang from my neighborhood. My involvement with the gang sent me down a path of drug addiction that lasted nearly fifteen years. My addiction clouded my judgment and led me to stay involved with the gang. In that time, I burned bridges with family members and people in my community who tried to help me and committed crimes that I regret sincerely.
  - 2. After my last conviction, I decided to make a change and move past my mistakes. I resolved to get clean once and for all, and I have been clean since my release in May of 2018. I view my conviction in 2016 as a blessing in disguise and a moment that ultimately saved my life. Since my release, I have worked hard to become a new man.
    - a. I have stayed clean for the past five years.
    - b. I successfully completed probation from my 2016 conviction.
    - c. I married my girlfriend, who supported me throughout my addiction, and we have had two children. My family has become my whole life.
    - d. I have been steadily employed since my release, first working as an HVAC technician and now working as a hospital custodian.
    - e. Last year, I decided to go back to school, and this June I received my Associate's Degree in Air Conditioning and Refrigeration from Mt. San Antonio College. Attached hereto as <a href="Exhibit A">Exhibit A</a> is my A.S. degree.
    - f. I have volunteered over the past five years with the GYRD Foundation and with Homies Unidos in Los Angeles. In my volunteer work, I speak with kids from similar neighborhoods to the one I grew up in. I show them the reality of the gang lifestyle that they see around them, and I try to be a positive role model. I also help with food drives and other important work in the community. Attached hereto as Exhibit B is a Letter of Recommendation from the organizations I volunteer with
  - 3. As I have become a family man over the past five years, my primary focus has become providing for my family. I have been incredibly proud to earn my degree this past June and take another step to lead a normal life and be a role model for my kids and my community.
  - 4. I plan to use my degree in Air Conditioning and Refrigeration to become an HVAC contractor and start my own business to provide a better and more stable life for my family. However, my convictions are a roadblock for me to obtain my C-20 Contractor's License from the state, and I have been turned down for other jobs due to my record.
  - 5. I take full responsibility for my past actions, but I believe my record does not reflect the man I am today. I have moved past my addiction, and with it, I have left behind the gang lifestyle that nearly ruined my life. Instead, my time is spent on my family and my

community. I am asking the court for dismissal to give me a second chance to lead a normal life and help me build a successful future for my family.
