As a result, I began to deeply regret the decisions I had made as a teenager and young adult.				
4.	Since my incarceration, I have cut all ties with the people who served as negative influences in my past. Now, over twenty years later, I hope to finally move on, in both the eyes of the law and those of my community, from the bad decisions I made as a younger man.				
5.	In the years since my conviction:				
	a. I have completed three years of parole with no violations.				
	b. I graduated from trade school at the  A as a trained electrician. Copies of my diploma and transcript are attached as Exhibit A and Exhibit B, respectively. I am, as noted above, now employed full-time as an				
	c. I have been completely sober from any drugs or alcohol since 2016.				
	d. I met and married my wife, Together, and I made a decision to leave my past life behind and pursue a healthy family environment. We have four wonderful children, two of whom we adopted. Copies of the adoption order and approval certificate are attached as <b>Exhibit C</b> and <b>Exhibit D</b> , respectively. The wellbeing of my wife and children has played a significant role in the reconsideration of my past life choices and has motivated me to continue to turn my life around.				
	e. I gave my life to Jesus over ten years ago. Since then, I have become heavily involved in my church, so a part of my involvement with the church, I regularly volunteer with the usher team, altar team, and sound team. I also participate in many church events during Thanksgiving and Christmas. A letter of support from our pastor is attached as <b>Exhibit E</b> .				
6.	My wife,, is my biggest supporter. She believed in me when I did not believe in myself. Now, I have a purpose in life as I work to support my wife and children. We are raising our children to respect and believe in themselves so that they can accomplish their				

- goals and achieve their dreams. I want to break the cycle of familial dysfunction and raise my children in a healthy and loving home.
- 7. In addition to my wife, I have a large support system around me. Pastors from our church regularly invite me to social events and take time to invest in my continued development.
- 8. My criminal record has made it difficult to obtain employment in the past. Further, when seeking to adopt our children, my record caused delays in the approval process. I would be very grateful to not have the stigma of my conviction follow me through every step of my life.
- 9. I respectfully seek expungement of my convictions stemming from the poor decisions I made over twenty years ago. I want to overcome my past and bring dignity to my family. I hope to no longer be known as a former felon. Instead, I hope to be known as a loving father, husband, and follower of Jesus. I have learned from the mistakes of my youth and expungement of my convictions would help to give me greater self-confidence and also a small measure of validation of the man I have become. I hope to finally put these mistakes behind me and be judged solely by the content of my character going forward.


